PLAYER CONDUCT REPORT FORM

Notes:

Referees will appreciate that it is not appropriate for action to be taken by England Squash & Racketball in relation to individual relatively minor incidents of misbehaviour or non-compliance with the Rules of the Game. However, the Association is determined to uphold standards and will not only act on individual cases of serious misconduct, but will also impose penalties on regular offenders of a smaller degree.

It is essential that every England Squash & Racketball member completes and returns a form to England Squash & Racketball when forced to impose conduct penalties WHATEVER THE EVENT OR LEAGUE AND CALIBRE OF PLAYER CONCERNED.

The System:

Players will accumulate penalty points for each conduct offence: Stroke, 1 Game, 3

- NB: (1) Only the most serious infringement in a single match shall be used for the purpose of points accumulation.
 - (2) There is no penalty point provision for disqualification, as this would be dealt with by the England Squash & Racketball Disciplinary Panel on an individual basis.

Players will invoke **automatic** bans for reaching the following levels in12 month period:

3-5 Points accumulated - 4 weeks ban

An accumulation of 6 points or over during a 12 month period shall result in an England Squash & Racketball Disciplinary Hearing.

If a player is subjected to a ban in each of two successive years, a further sanction may be imposed by the England Squash & Racketball Disciplinary Panel.

A ban would prohibit a player from competing in any England Squash & Racketball Sanctioned Event or Metropolitan/County/National League during the period concerned.

Any bans will commence on the third Monday after the details of the conduct offence are received by the England Squash & Racketball office. However all periods of bans will fall within the months October – April and may be carried over if necessary.
